The Outer Banks Preservation Association, Inc. was formed as a public voice for concerned citizens and beach user groups interested in preserving the traditional way of life prevalent on the Outer Banks. This lifestyle, based on independence, self-reliance, protection and preservation of natural resources and strong family and community values, has always regarded free and open access to the sound and ocean beaches as an inalienable right. Further, this right has, in the past, been assured by the National Park Service to the residents and visitors of the Outer Banks.

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the Federal, state, or local government for a public purpose. any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments, and distributions in furtherance of the purposes set forth in Article III. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not exempt from federal income tax under section 501(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
