## 2/26/2007 Buxton

Issues

- Conflicts increasing between user groups coincide with an increase in visitors and a shrinking beach
- Long established pedestrian beaches have been opened to ORV use
- Current management of CAHA is under political pressure initiated by ORV advocacy groups
- Current established higher use season is too short
- Establish year around pedestrian access only areas
- Make sure operating rules insure safety of pedestrians and protect the resources
- Economy/communities
  - Positive/negative- degreased visitation may be due to crowds and ORV use in the beach
- Ramps at campgrounds to avoid high pedestrian use areas = more
- Econ- decreased visitation may be due to beach closures
- Effect of Sea Level Rise on ORV plans and nesting habitat

#### Alternatives

- Need an alternative on utilizing disturbed sites to develop habitat for protected species.
- NPS should lead efforts to develop a night sky/lighting program to protect wildlife and light pollution
- Need plan for SGA level increases
- If it's not broken, don't fix it
  - Everything working fine!

- Relocate turtle and bird nests captive breeding program.
- Garbage receptacles at all access points and parking areas

### **Alternatives WB-3**

- Need more enforcement in Now and into the future for anticipated increase in visitation
- Make public ORV violations (public humiliation), Stiff fines, local newspapers

- Delaware- Cape Atlapean (sp?) at the point- check for permit example
  - Should have safety equipment, and some people from outside the area have tried to drive on the beack with a car (non-4 wheel drive) is better now that NCBBA signs are up, could include info in brochures
  - Narragansett Bay Area- 4' high snow fence with covered top to keep gulls out and holes in fence for birds to go in and out (adults could bring food in to chicks)- kept the cats, dogs, skunks out to protect the young
  - $\circ~$  Early in AM, see if lot of cat, dog, and fox tracks- on the Hatteras Island
- Should be an expensive permit for anyone to drive on the beach (\$50-100 per year)
  - Are too many young people from out of state that come here and doing donuts and speeding and being inconsiderate to fisherman and driving bird nest closures (would be a deterrent). Safety is a concern with young people in big trucks (large wheel trucks) when children are on the beach. Large wheel trucks is more the issue than # trucks
  - Sept-April is the best fishing, could close then like Nags Head closes in summer to driving on the beach, but some like to take children and equipment (beach chairs etc.) in vehicle to beach in summer.
  - Island Beach State Park- NJ- limited # permits, when you turn yours in then it goes out to someone else also seasonal permits do full inspection of vehicle safety equipment.
  - No Wildwood 3 day permit and inspect truck
- Develop alternative park uses (off shore fishing; use west of NC-12, etc) to offset potential Regional economic impacts
- Increase National Resource interpretation to elicit dialogue to spotlight needed Endangered Species Natural processes and their importance to the regional economy.
- Most suitable bird habitat areas on the beach should be set aside exclusively

   Ex: Cape Point and Areas near inlets
- No driving permitted in areas in front of houses
- Remaining areas should be split btw motorized use permitted and non-motorized use
- Year-round protection for sensitive species habitat areas
- All sensitive areas should be mapped within plan and clearly marked/designated
- Goal of plan should not be to minimize adverse impacts to sensitive speciesgoal should be 'eliminate; adverse impacts.
- Should create a permitting system for vehicles based on the quantified carrying capacity of the natural systems (carrying capacity can change over time)
- Plan should recognize that contemporary ORVs are not he traditional use
- Plan should take into account that there are fewer wild areas within the park due to sea level rise and adjacent development and larger numbers of people
- Support zoning concept in prelim Alts board
- Zoning should be adaptable to take into account dynamic nature of park
- Access based on percentage Alt.
  - The % based on non-ORV use should not be diminished

#### Size of resource mgmt zones should not be reduced to accommodate more visitors – priority should be resource

- Use the practical successful knowledge from CACO and FIIS ORV management plans which used compromise and continued a good local economy
- Use locally contracted ORV buses during heavy summer visitor use driving behind the dune line to transport visitors along the beach
- Charge an ORV permit fee that will sustain all mgmt. actions needed in this plan
- Minimizing ORV impacts may not allow for sufficient natural processes on the barrier island habitat and this may continue the decrease of end. Species leading to species extinction. Redirect the primary objective of the EIS to wildlife protection but focus on ORV use in the rules to entered into the CFR to be developed to protect wildlife
- Keep beaches open at night for rec. uses
- Stop use of fireworks in park
- Develop research study to help with turtle nest relocation program to maximize numbers and gender
- Educate visitors who use beach (weekly rentals)
- ORV training online- with certificate of completion
- Why isn't the title Cape Hatteras National Seashore recreation area?
- Issue statements overly focus on negative impacts of ORV use. Positive impacts should also be addressed
- Feel regulations are closing in-feels like plan is to close beaches to ORV use eventually
- Would accept a permit system if it kept the people who break rules off beach at Nags Head (past 30 yrs at least) can drive on beach with a \$25 permit. Keep open what is currently open. DO NOT want to see a " 1on 1" off capacity control system
- Permit would provide funds to help NPS operations
- Access points
  - Ramp information should include adequate information for new users. i.e. rope, tire pressure, equipment etc.
  - Make this a "do" list. Speed limits should be marked and enforce
  - Develop beach watch program to assist NPS with enforcement
  - o Develop mile marker system on the beach
  - Public access walk over signs "public access"

- No needs to restrict activity between nest and water 'til hatching (or no need to too low temp), protect nests that have flooded and have non-viable eggs. Want reasonable mgmt. practices- should protect viable nests and give up on non-viable ones that won't hatch.
- Important to keep beach access open and maintain facilities (restrooms and fish cleaning tables)- tourism is important.
