In 2004, approximately 50 permits for commercial fishing were issued at Cape Hatteras. There are two areas on Ocracoke Island on the soundside designated for commercial use only. One of these areas, open only to commercial fisherman to fish for livelihood, is under a key system. Residents who qualify fill out a form and receive a key to access the area, which is used mainly for boat storage. Approximately 24 keys have been issued
