Dear Mr. Hathaway:

I appreciate your passion for the beautiful beaches of the Outer Banks, fishing and your interest in the beach driving issue at Cape Hatteras National Seashore. I know beach access is really important to you.

The Plaintiffs have recently asked the Court to impose a complete year-round ban on ORV use at six key sites (Bodie Island Spit, Cape Point, South Beach, Hatteras Spit, North Ocracoke, and South Ocracoke) and other full beach closures during the breeding season at other shorebird nesting sites. The closures requested by the Plaintiffs are based directly on the recommendations of U.S. Geological Survey (USGS) scientists who were hired by NPS early in 2005 to develop management recommendations for species protection at the Seashore. The USGS is considered the scientific research agency within the Department of the Interior.

To put it simply, we are in a difficult situation. For over 30 years NPS has failed to meet the legal requirements identified in two Executive Orders and a federal (NPS) regulation that requires us to have an ORV management plan and regulation. Despite the best efforts of the Superintendent and the park staff to implement the Interim Strategy, the simple fact is that we do not meet the legal requirements until the ORV management plan and regulation are completed, a process which could take up to three more years.

It seems likely that the outcome of the lawsuit, however it is resolved, will directly affect the management of ORV use at the Seashore for the next few years, while NPS continues with the ORV planning and negotiated rulemaking processes that are underway. Our hope is to reach a mutually agreeable solution for the long-term plan and regulation that will have broad public acceptance and withstand legal scrutiny. As these processes proceed, it will be important for interested parties such as you to remain involved and to submit public comments on the proposed plan and regulation when the opportunities are presented.
