- 2. I'm forwarding your second question to **Charlie Sellars** since he is the Maintenance and Facility Management Chief and will be the person who has to construct and operate any new facilities. Also, Mike may want to weigh in. Other than placement (siting) and numbers of facilities, I don't know what would differentiate this between alternatives. It would seem that other factors are more related to overall operation of the Park, which is a GMP issue, than just ORV management.

Maybe we could keep it as it is and provide justifications for the different speed limits? Do you know what Mike's thoughts are on this topic?
- 2. Restroom facilities Mike indicated that he wanted a row in the matrix for restroom facilities. However, we didn't discuss the issue in any depth at the Alternatives Development meetings in March. What would be some options that could be put into this row to meet the objectives of the plan and differentiate the alternatives?
