Any update Mike? I'll begin forwarding calls on this to the Ranger Division as I have no update or change in status to these questions.

Excerpt from June 12, 2008 Beach Access Report:

We have no update on the "water boundary" issue as of today's date. We frequently hear the question – "can I walk in the water around a full beach closure to access those stretches of beach that are restricted, open beach for pedestrians?" We realize the situation can be confusing. From a legal point of view, the NPS jurisdictional boundary is clear. It is the mean low water mark. On the ground, however, when it is not low tide, it is unclear exactly where the boundary is located or how the public, or the rangers who enforce the regulations, can definitely determine its location at that precise time. We are working with staff, Solicitors, and the U.S. Attorney's Office to clarify, and hopefully simplify, this issue. We will provide clarification as soon as we have a definitive answer.
