Jim Harris is reporting that you have three different speed limit signs in an area approximately one mile in length from Lighthouse Road, over Ramp 44 and then as you exit onto the beach at Ramp 44 and continue on out on the beach.

- 1) 25 mph speed limit sign on Lighthouse road
- 2) 15 mph speed limit sign on Ramp 44 (prior to cresting the dune/ramp area)
- 3) 25 mph speed limit sign after you exit onto the beach at Ramp 44 (out on the beach)
