Dear Friends,

It has been a long year for our community. Our beach closures have had enormous impacts on our lives and the lives of those that visit here. While some businesses can tout a spike or a break even in this year's business, most have suffered a loss. I realize that the national economics and high gas prices have also played a part in this decline, but I feel certain that on the Outer Banks, a lot of the loss has to do with the beach closures. There is little that we can do about the national economy or gas prices, but we can Fight for our Beaches.

I am proud of our local community and the way we have come together in this fight. Many business's still state "Save Our Beaches" on their marquees, and most have contributed to the fight in numerous ways, including donations for fundraisers, collecting donations in our "Dollars and Cents Campaign," or both. Most of you have shown your support through volunteering or by taking part in one of the various awareness programs -- from the "Please Help Us" community meetings to the fundraiser barbecue and any of the other projects. For that we are all thankful.

All of these projects thus far have been geared towards ourselves and the raising of attention to this situation. Now the time has come to take this in another direction. Day after day, I hear the frustration and anger of so many people within this community, and I believe the time has come to take this anger and frustration to the faces of those causing it.

On Monday, Sept. 8, there will be a regularly scheduled meeting of the negotiated rulemaking committee at the Avon Fire House, and I think it's time to show these people just how we feel

about what they have done and how they have treated us. The RegNeg process has from now until January before its work is over, and I hate to think that we allowed this process to take place without once showing up in force to express our feelings. For every meeting, the same 30 to 40 people from the public show up to express their displeasure, and, truthfully, that just isn't cutting it.

The time has come to show them we are very upset by their lack of concern for lives and livelihoods. This is your chance to see Derb Carter, Jason Rylander, Walker Golder, and Sidney Maddock face to face and let them know that you are tired of the neglect, lies, and outright disrespect.

I am asking that each of you who can join us at 7 a.m. on Sept 8 to do so. We plan on lining the highway, so that these people have to drive by us in the morning on their way to the Fire House and so they can see that the people are not happy with this mess as they have so proudly touted to every form of media possible. As long as they can continue to show little resistance, then they can continue to distort what is the actual truth.

I am asking that every person who can join try to stay until 11:30 when the public comment starts. While there is no way each of you could speak, I have come up with a way for each your voices to be heard.

It has recently been brought to my attention that Dare County has requested to film each of the remaining meetings for broadcasts on Channel 20, and the county officials were told that the full negotiated rulemaking committee would have to give its permission to do so, while the NPS also asks permission from their higher-ups. This is supposed to be a public process, but it seems public only if you can take time out of your daily life to be a part of it. The enviros have recently shown their true intentions of turning Bodie, Hatteras and Ocracoke islands into "Wildlife Observation Areas." The upper levels of the NPS have left us hanging in the court of law and before Congress.

How long will you continue to allow this to go unchecked?

Join Us. The time is now to strike with all we have. Let's show the environmentalists and the NPS that we will not tolerate the way we have been treated thus far. This is a public process and the other side has done little to respect the public or our representatives. Let's go stand behind Warren Judge, Allen Burrus, and the numerous other people who have been fighting for us.

Join Us.

I'll be leaving to go out of town early Wednesday morning, and I will not return until late Sunday evening. I will have limited access to the Internet, but I believe I will have phone service. So, if you have any questions please call me or e-mail Lynn Murray, whom I will speak with between now and then, and I will answer any questions.
