Dec 5, 2008 call with Sandy, Lori, Doug, and Nancy

1. Data needs/items of discussion related to no action alternative analysis:

a. Wildlife and Wildlife Habitat: Discuss the species being covered in this section. As the document is coming together, it appears that impacts to marine species and nonpredator mammal would be negligible. Discuss the possibility of dismissing these items

Sandy: NPS managing mammalian predators under IPSMS, so can be dismissed in EIS. CAHA is giving out educational materials on stranded marine mammals. Sandy said that this topic could be considered but dismissed. Sandy: fish can be dismissed because CAHA has no water jurisdiction on the ocean side.

b. Park Operations and Maintenance: Need information on what maintenance duties/costs were under the IPSMS/EA
