I would rather the conversation stay away from the success of nests in ORV areas, because I believe that this information can be skewed (by both sets of opinions) to show support for one side or another. Is it okay if we keep individual nest successes internally for a little while so that I can have more time to fully review the data? We also still have one nest that has not hatched, but that is still viable. By viable I mean that when I opened two eggs on the top of the nest last week, I found that both eggs contained live embryos. This generally means that the rest of the nest is also still viable.
