Attached is a document I started but never finished (made it as far as 1998-2002) that list possible take incidents and storm impacts from old annual reports. I am not that confident in the accuracy of the information. Don't know if it is worth finishing (2003-2008) or not. I think your version for 2007 and 2008 is a more articulate and "crisp" listing of possible take incidents than what I was able to do for the earlier years. Frankly, I had difficulty interpreting and summarizing the descriptions of incidents, since the references in those old reports were often vague or confusing. In any case, here is a summary of some of the earlier years, if it is of any use to you.

#### Summary of Sea Turtle Incidents and Weather Impacts from Annual Reports

## <u>1998</u>

Incidents:

- 2 cases of holes dug into nest site near Salvo
- Holes were dug in posted nest the day after it hatched
- 2 cases of ORVs driving into posted nest relocation sites
- 3 crawls obscured by ORV tracks; could not locate body pits or nest cavity
- 3 cases of ORVs driving into posted nest relocation site between ramps 30 and 34
- 3 cases of ORVs driving through posted nighttime nest closure near Ramp 49
- Hatchlings crawled toward lights from the lighthouse parking lot, but eventually entered surf
- 12 misoriented hatchling tracks (some east, some west) on South Beach
- Hatchling tracks led into dunes near Hatteras Inlet

Weather: Hurricanes Bonnie, Danielle and Georges: 5 nests lost; 11 more had low productivity

### <u>1999</u>

Incidents:

- 3 cases of intentional disturbance of posted nests (digging into nest)
- 2 cases markers used to locate nest cavities were vandalized
- Canadian Hole relocation site moderate foot traffic (repeated violations) in closed area
- Canadian Hole relocation site footprints and dog tracks on possible nest site
- Ocracoke human tracks on top of a nest that had hatched the previous night
- 2 crawls obscured by ORV tracks; could not find body pits or nest cavity
- 3 hatchling misorientation incidents (nests # 10, 20, and 21)

Weather: Hurricanes Dennis, Floyd, Gert and Irene. Total: 27 nests and 6 digs lost

## <u>2000</u>

Incidents:

- 4 nests missed that were later discovered when exposed by erosion or when egg hatched
- People in ORV got out of vehicle and approached turtle on beach; turtle retreated to the ocean without laying eggs
- Hatteras Island 4 nests disturbed and eggs broken
- Previously undiscovered nest found by visitors and reported
- Previously undiscovered nest reported when hatchling were observed by visitors near Ramp 49
- Avon visitors observed turtle laying eggs; when staff responded, found 4 eggs damaged or disturbed
- Visitor marked a nest with fishing pole holder and broke eggs
- 2 cases of people digging in sand within nest closures on Rodanthe and Avon beaches
- Ocracoke humans disturbed sand covering nest

- 2 cases nest signs vandalized
- 130 vehicle tracks within posted closures; 5 cases of ORVs driving directly over nests within posted closures
- South Beach (nest # 7A) 10 hatchlings rescued as they crawled the wrong way toward Frisco and Hatteras Villages
- Hatchlings from nest # 42 went in all directions except toward the ocean. 1 dead hatchling found in tire track 200 feet north of nest
- Dog digging in nest exposed eggs
- Dog attempted to dig into nest cavity

Weather: No hurricanes. Three low pressure systems. Total: 9 nests lost to erosion; 10 nests buried with 30-50 inches of sand

## <u>2001</u>

Incidents:

- Between Ramps 23 and 38 4 cases of ORVs driving through closures and nest site
- Avon visitors with flashlights surround turtle on beach; turtle retreated to ocean without laying eggs
- 2 cases of people attempting to dig into egg chambers
- 4 cases of nest protection signs being vandalized
- 4 cases of nest markers being pulled out
- 102 sets of ORV tracks within nest closures, including 6 cases of breaking through signs on upper beach and 4 cases of driving over nests
- one crawl obscured by vehicle tracks within 1 foot of nest cavity
- Ocracoke dogs tracks along side sea turtle tracks on an aborted nesting attempt

Weather: Low pressure systems and Hurricane Aaron. Total: 8 nests completely washed out and most nests that were overwashed did not hatch

## <u>2002</u>

Incidents:

- 2 cases of unrecorded nests being discovered later, including one which fox had dug into cavity and one that was discovered upon hatching
- one visitor report of hatchling emergence from unreported nest; nest site could not be located by staff
- one case of visitors disturbing nest before turtle patrol arrived
- one case of nest being tampered with during incubation period
- 3 cases of nest protection signs being vandalized
- 6 cases of nest markers being removed
- 7 cases of ORV damage to closure signs
- 1 case of hatching tracks obscured by ORV tracks within closure; unable to confirm fate of hatchlings
- one crawl obscured by ORV tracks; could not locate body pits or nest cavity
