Mike-

I wouldn't spend any time trying to analyze Larry's data because it is incorrect!!! We don't know where his numbers came from. We have to be cautious when we refer to nest numbers recorded for the month of May because until recently we did not have staff searching for nests in the beginning of May. Only in 2007 did we have staff searching for nests starting on May 1. From 2006 and prior staff started searching May 15th or later. Any nests that were found in early May prior to 2006 would have been incidental (e.g. LE or public reporting an activity). People were not actively searching the entire beach on a regular basis. For this very reason, FWS required us in the BO to start our surveys on May 1st.

I had Michelle look in the database for **May** nests and she came up with a total of 22 nests of which 17 hatched for the period of 1997-2007. We had an additional 2 nests in May in 2008 both of which hatched.

Without spending any time checking the records and his math to absolutely <u>confirm</u> the accuracy of it, <u>would you please give me your</u> <u>impression of whether it seems reasonably accurate and credible.</u>

I want to do some graphing of the data (I'll do it), which may help inform the Natural Resource subcommittee discussion about how much risk to turtle nesting would occur if night driving restrictions started in early May vs. mid-May vs. late May, etc. I don't want to spend time graphing it if we think the data is unfounded or grossly inaccurate. If we think the data is reasonably credible, then I'll do the graphing and still put in a caveat that NPS has not confirmed the accuracy of the data.

Note: I know you are swamped. I'm not aware of any more things to add to the "to do" list.



Natural Resources Subcommittee Sea Turtle Information, January 2008

The below graph indicates the lay dates for the 983 nests laid on CAHA between 1997 and 2008. Nests that did not have known lay dates (i.e. were found only when hatchlings emerged) are not included in these totals. The number of nests by year may differ slightly than what was reported during that time, but these numbers represent the most accurate information known and are reported as such in the 2008 Sea Turtle Annual Report. It is important to note that these numbers are misleading. Prior to 2007, turtle patrols were conducted between May 15 – Sept 1. In some years, patrols did not begin until June 1. Any nests found before the start date or end date of turtle patrol were found by chance (i.e. visitor reporting, staff on the beach, etc.) since no coordinated, scheduled patrols were conducted. It is unknown how many nests were missed during these times. Beginning in 2007, FWS requires CAHA to begin patrols May 1 and continue until Sept. 15th in order to reduce the chance of missed nests.
