I spoke with Mr. Stokes just a little while ago, only one message left for me from after 1 p.m. today. He was asking about launching a motorized vessel from the Oregon Inlet Spit to access the bait pond, since the prenesting closure prevents driving to the pond. He and I both recall that we allowed motorized vessels to be lunched from the ocean beach to access Cape Point last year. Checking the Compendium I find no such provision listed for either Bodie Island Spit or Cape Point. With the season upon us, we probably need to get guidance out on this ASAP. If we are going to designate all or portions of the ocean beach as launch sites (we should probably be consistent with last year), lets get that formalized in the Compendium and out to the staff.
