 >Thank you for your kind words. I had a good vacation, but it is also good >to be back.
>With regard to the situation at Ramp 23, as of Monday there was still at >least one least tern chick in the area. Once it has fledged and we are >sure that breeding activity has concluded, we will be able to remove the >buffers, including the expansions for the deliberate violations, and reopen Ramp 23. Paragraph 17 of the consent decree provides that when nesting >(i.e., breeding activity) occurs in the immediate vicinity of paved roads, >parking lots, campgrounds, buildings, and other facilities, NPS retains the >discretion to provide resource protection to the maximum extent possible >while still allowing those sites to remain operational. Though there have
 >while still allowing those sites to remain operational. Though there have >only been a limited number of situations in which this provision has >applied (e.g., Sandy Bay and a very few instances of breeding activity or >deliberate violations near village borders), we have used our discretion to >manage such closures in a way to keep such facilities, including houses, >cottages, etc., functional. In essence, the same rational was applied to
 >cottages, etc., functional. In essence, the >the recent violation of the nesting closure.
>With regards to how the village areas will be managed after September 15 > (i.e., whether they will be open or closed to ORV use), I had hoped that the RegNeg Committee, the Village Sub-committee, or the Integration Group would be able to make a consensus recommendation on what the village beach >policy should be, because I would have gladly implemented it, but as you >know that did not occur. Since there are obviously contradictory opinions >about how the village areas should be managed during the off-season and >even conflicting opinions on what dates constitute the "off-season", I've >decided to stick with the status quo from recent years for one more year >and use the NEPA process to make the final decision. I believe this >approach is reasonable under the circumstances, avoids setting a new >precedent just before and during the upcoming public comment period on the >DEIS, and gives all involved the opportunity to definitively resolve the >issue through the NEPA process. When the draft plan/EIS comes out for >public comment, it will have a range of options, including different >approaches, dates, etc., for managing the village areas for consideration >and comment. After the public comment, NPS will make an informed decision >in the final EIS and Record of Decision and thereafter have a long-term >policy.
