The issue of removing sandbags is sensitive in general to North Carolina, but in particular with this particular adjacent landowner. Before we go too far down the road of removing the sand bags, we need to be absolutely sure where our boundary is, where the bags are in relation to our boundary, whose responsible for removing the bags, and what the current legal requirement is regarding the bags. The decision to remove the bags or not will be made at HQ after we gather some information. In the mean time, we need to determine how we can safely patrol these areas without removing the sandbags.

Darrell,

I am not sure of the process on this, but sandbags are supposed to only be a temporary solution. You are required to get a permit from CAMA in order to install sandbags. Given that the sandbags are actually on our property, in this case the owner should also have a permit from CAHA. I believe that last year CAMA (or the state, I can't remember which), sent notices to all residences and businesses along the Outer Banks that required them to remove their sandbags. I am not sure if this property was among them, but I had heard that it was. However, this summer the governor halted the process of sandbag removal. Now I do not know what the regulation is. Here is an article about the latest developments:

This is also the same property that installed illegal sand fencing this year. The fencing is against state guidelines, and we reported it to CAMA. The way the sand fencing was installed actually increases the erosion of the area, as well as essentially blocks nesting habitat for sea turtles. Internally, the issue was reported to Meghan Carfioli. So far the owner has not redone the fencing.

To all,

We should do everything we can to avoid driving over sand bags, which should minimize the safety risks for employees removing a hindered vehicle, minimize the risk of a vehicle being stuck in an incoming tide, and reduce the public scrutiny of our actions. It is unfortunate that this happened, but it provides us an opportunity to re-evaluate what we do and hopefully establish a safer and better way of doing things.

Thayer,

Since the UTV's are primarily used to help us patrol for sea turtles, I would like RM to develop a way to maintain patrols while keeping us from driving on sandbags. This may require us to alter patrol routes, patrol schedules, or maybe even consider

eliminating patrols for beaches that are not suitable for nesting based on observations and nesting occurrences. Once you have developed a plan, please work with Paul and Dennis to determine the applicability for their operations. If it is not safe or appropriate for RM to drive in an area, then it may not be appropriate for other operations as well.
