Doug,

Attached is the letter (short and sweet version). Michael and I worked on it and we decided to insert the one sentence he crafted as highlighted below:

We have completed a number of studies meant to identify historic resources, including an historic resource study and an ethnographic overview and assessment. Mostly as a result of NPS efforts, the Outer Banks now have ? individual sites and ? districts listed on the National Register. In addition, we are currently seeking funding to update our historic resources study, since we recognize that a number of properties may have attained historical significance in recent years. We welcome your input when that project gets underway. **At this point in time, we have been unable to determine whether there are Outer Banks communities that have cultural practices and beliefs associated with the specific beaches in question. Also, we do not have sufficient information that shows that the association between any community's cultural practices and beliefs about specific beaches are integral to the continuing cultural identity of that community.**
