Hi Ted,

I believe the discussion may have been misunderstood. We talked about having previously held around five public meetings during earlier phases of the ORV management planning process, which has usually included an "out of town" meeting in Raleigh and one in either Washington, DC or Richmond. For the DEIS, we are contemplating holding five public meetings again (three on the Outer Banks and two "out of town"), but this time we are thinking about holding one meeting in central North Carolina (e.g., Raleigh) and one in central /eastern Virginia (e.g., the northern Hampton Roads area). I imagine anything we do in terms of meeting locations will be subject to criticism, but we have not determined the exact locations, so I appreciate the input.
