The exact release date of the DEIS is still undetermined, but it is getting closer. I would characterize it as "soon" (as within the next month or so) rather than "imminent" (as within in the next few days or week). This week we are fine tuning a few remaining small sections of the document. It will take about a week for the editor to fully format the document for publication after all final edits are done; then the "final" publication-ready document will be submitted through channels to DOI for approval (which I'm told will take at least several weeks) to publish the Federal Register notice that kicks off the 60-day public review and comment period.
