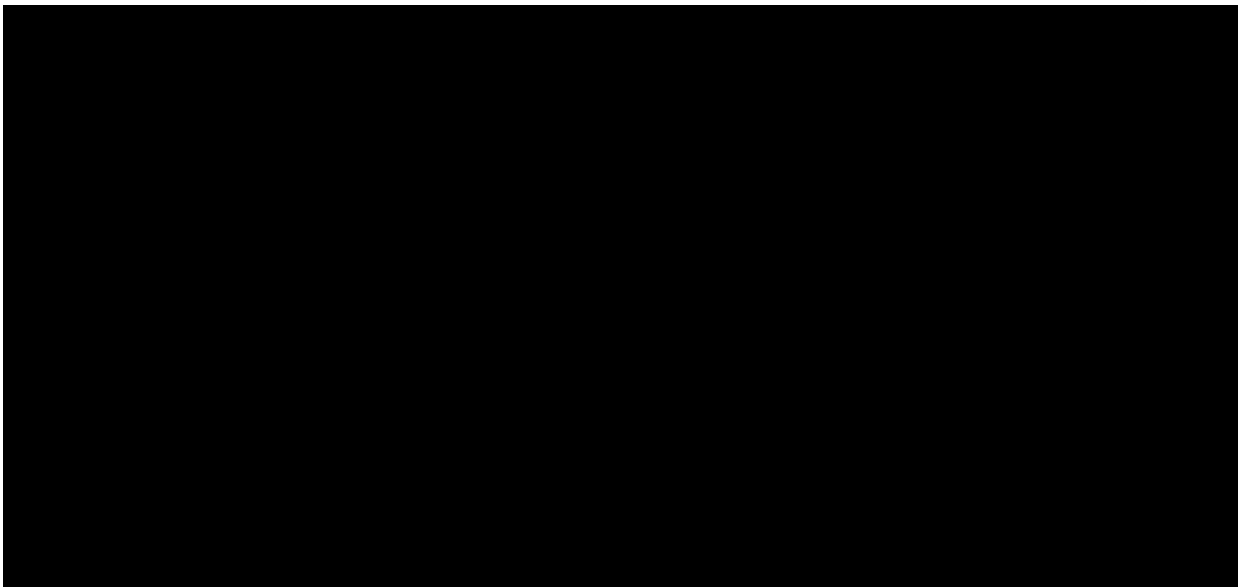

See attached draft report. By the end of the week, I would appreciate any comments or recommendations you have for me to consolidate and submit to the cultural resource advisors. Particularly pay attention to the footnote on page 2. There probably is a better way to word the statement, "The lawsuit and subsequent decree undermined a negotiated rulemaking process with stakeholders." Note: I will comment on using consistent language for "designated critical habitat for wintering piping plover" (the author often leaves out "wintering"). Given the draft "Conclusion," once the report is finalized we may need to discuss "next steps" for how to address the situation.
