Hi Mike,

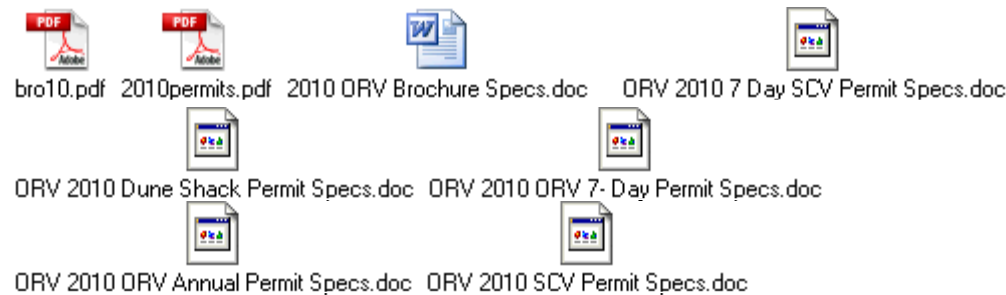
I will put samples of the 2009 ORV permits in the mail. (2010 have not arrived yet) I recently surveyed all 2009 permits and only have a few replacement permits on hand. What I do not have available is a Self-Contained Annual Permit or the Dune Shack permit, but you can view them electronically in the attachment below. Please provide an address where you would like these sent. Also, regarding vendors, all orders must go through your regional Government Printing Office. You must provide specs and you may also request a vendor. However, it does not always mean they will be awarded the job. Annually, the vendor we request for both the permits and the brochure is Douglas Screen Printers from Lakeland, Fla.. While they always seem to be awarded the permit jobs, they are not always awarded the Brochure job. I suspect it is because they are outbid.

Other forms that are sent along to GPO with each spec is the "Credit Card Worksheet" and the "Desktop Publishing - Disk Information" form. All of these forms can be downloaded from the GPO site. *If you suspect the job will go over \$3,000, it is handled through the park's AO or regional contracting office. All forms must accompany order. I consider each job a separate order and work directly with GPO.*

*Also, we use a local graphic designer for our permits and brochure. If you would like her information let me know.*

Mike,

It's good to hear the Cape Hatteras ORV program is still moving forward.

Rob from Art's Dune Tours is issued an Incidental Business Permit to cover his operation. They are not required to get an additional ORV permit. The IBP identifies things like the equipment that is required in the vehicles, the requirement to watch the educational video, etc.

We also have administrative permits that are issued to dune shack dwellers, American Lighthouse Foundation vehicles, etc. These are issued at no charge. We use these administrative permits to cover the people that have a seasonal permit and sell their permitted ORV and buy another vehicle they want permitted. Or, for the seasonal permit holders that are involved in accidents with their permitted vehicle and need a new sticker for the replacement vehicle. These administrative permits start at 3900 and are the same color as the ORV permits that are being purchased.

Permit and permittee information is entered into a database when the permit is issued. This database was created by a Seashore computer programmer when we added advance sales for the 200 weekly permits in 2006.

I'm sending this email to Janet. She'll provide you with a color copy of the seasonal and weekly permits, along with the ordering information. She may have electronic copies of all items.

You may use me as a point of contact for CAHA staff.

Subject: ORV permit question

Hi Craig,

April 10 is coming soon, so I know you are busy. We recently released our draft ORV management plan/EIS (DEIS). An issue has come up that we did not fully cover in the draft plan. How does CACO handle ORV permits for commercial operators, if any, who operate ORVs to conduct the commercial activity that is under a CUA (e.g., Art's Dune Tours). Is the CUA operator required to also obtain an ORV permit through the usual process, and pay the ORV permit fee too, or not? (or) Is the use of an ORV to conduct the authorized commercial activity covered by the CUA (i.e., no separate ORV permit required)?

We also have a few questions about your ORV permit program (e.g., what sort of database do you use to keep track of permits issued?). We would appreciate it if you could have someone send us a color copy of an annual and a weekly ORV permit, along with the ordering information (vendor, specs, cost, etc.) for purchasing the permits. While we have made no final decisions yet, all of our action alternatives include ORV permits and we are simply trying to gather background information on how to set up a permit program, if the decision is made to do so.

Lastly, who would be a good point of contact for CAHA staff to contact regarding your ORV permit program, if we have further questions?

### OFF-ROAD VEHICLE (ORV) GENERAL INFORMATION

The Off-Road Vehicle (ORV) sand trail on the northern-most portion of Cape Cod is comprised of miles of unspoiled beaches managed by Cape Cod National Seashore, a unit of the National Park Service. The trail begins at Race Point Beach in Provincetown and ends at Long Nook Beach in Truro. Weather and beach conditions permitting, the off-road corridor is open from mid-April to mid-November. Permits are required. To obtain a permit, four-wheel drive vehicles must pass a safety inspection, owners must view an educational program, and purchase a permit. Outlined in this brochure is information about obtaining a permit, requirements, and regulations for driving on the off-road corridor at Cape Cod National Seashore. Information is also available online at [www.nps.gov/caco](http://www.nps.gov/caco). Significant ORV closures have occurred in June and July.

### HOW TO GET A PERMIT:

Bring 4-wheel drive and/or SCV (self-contained vehicle) to Off-Road Permit Station at Race Point Beach, Provincetown, MA for a vehicle inspection between April 10 and November 15. If not the owner of the vehicle, you must have a letter of authorization and a copy of the owner's drivers license.

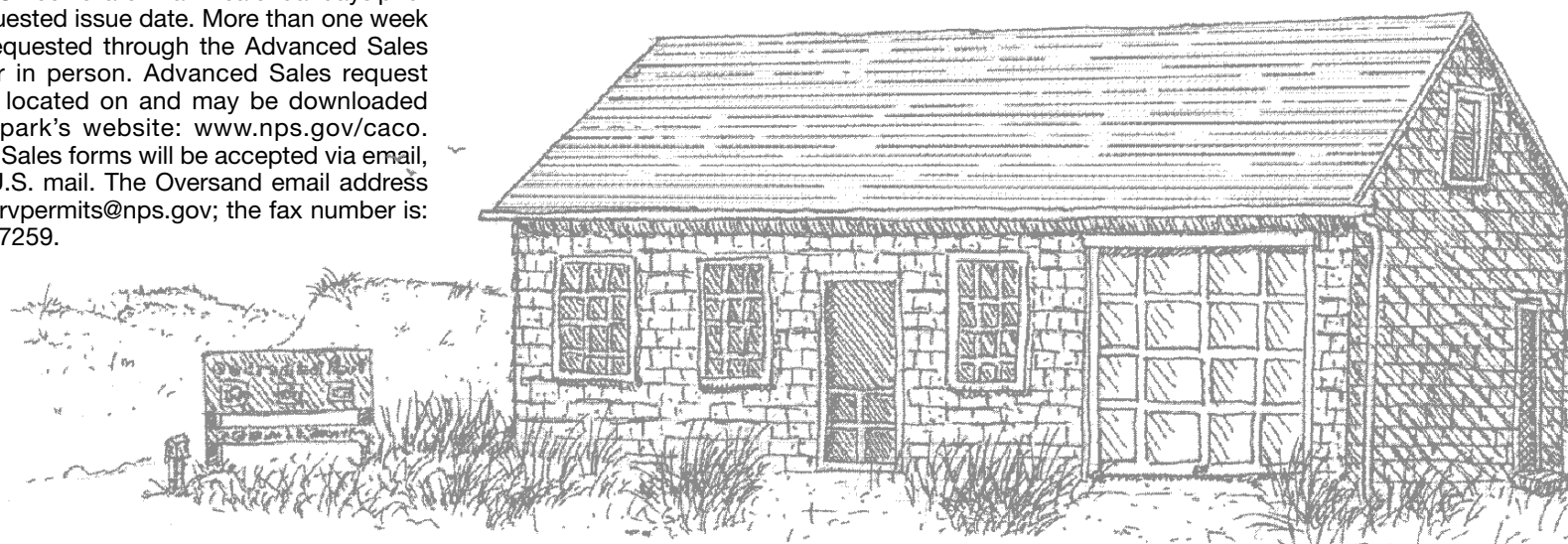
- Have all required safety equipment
- Show valid driver's license and registration
- View orientation program
- Pay permit fee (Cash or Traveler's Checks in U.S. Currency; VISA, MasterCard, Discover, American Express and Diner's Club)
- Agree to abide by National Seashore regulations and the "Low and Slow" initiative.

Permits are available on a first-come, first-served basis.  
**RENTAL VEHICLES PROHIBITED.**

### WHERE AND WHEN PERMITS ARE AVAILABLE:

Annual and weekly permits are issued from the Off-Road Permit Station at Race Point Beach, in Provincetown, MA. Permits may be purchased from April 10 until November 15, 8 AM to 4:30 PM, seven days a week, including holidays, on a first-come, first-served basis until the cap of 3000 annual permits for the season has been reached.

Weekly permits may also be purchased through the Advanced Sales System and must be made at least one week before the date of issue; the completed request form, with credit card/payment information, must be received by the Oversand Office no later than 7 calendar days prior to the requested issue date. More than one week may be requested through the Advanced Sales System or in person. Advanced Sales request forms are located on and may be downloaded from the park's website: [www.nps.gov/caco](http://www.nps.gov/caco). Advanced Sales forms will be accepted via email, fax, and U.S. mail. The Oversand email address is: [caco\\_orvpermits@nps.gov](mailto:caco_orvpermits@nps.gov); the fax number is: (508) 487-7259.



### PERMIT TYPES & FEES

**ANNUAL OFF-ROAD VEHICLE (ORV) Permit \$150**  
Four-wheel drive vehicle. Annual ORV Permit allows registered operators to drive on designated ORV beach routes from April 15 through November 15 and off-season with a Limited-Access pass.

**7-DAY OFF-ROAD VEHICLE (ORV) Permit \$50**  
Four-wheel drive vehicle. 7-Day ORV permit allows registered operators to drive on designated ORV beach routes for 7 consecutive days from the date of issuance between April 15 and November 15. 7-Day permits may not be upgraded to Annual permits.

**ANNUAL SELF-CONTAINED VEHICLE (SCV) Permit \$225**

**7-DAY SELF-CONTAINED VEHICLE (SCV) Permit \$75**  
Self-Contained Vehicle (SCV) or 4-wheel drive pick-up camper. Annual SCV permit allows registered operators to access SCV areas and stay overnight (up to 21 days from July-Labor Day.) An SCV is defined as a vehicle with a self-contained water or chemical toilet and permanently installed holding tanks with a minimum 3 day capacity for gray and black water. An SCV permit allows registered operators to drive on sections of the designated ORV beach route to park overnight in designated self-contained beach camping areas between April 15 and November 15.

*Vehicles operating off-road on Cape Cod National Seashore must pass a vehicle and safety equipment inspection and have a valid off-road permit affixed to the bumper of the registered vehicle. Permits are non-transferable and will not be issued to rental vehicles. All standards are subject to review and change annually.*

### PERMITS FOR NEW/DAMAGED VEHICLES

If your vehicle has been wrecked or sold and you have purchased an annual ORV permit, you must remove the permit from existing vehicle and exchange it for a new ORV permit at the ORV Permit Station at no cost. You understand that if the vehicle is sold or in an accident, and you need a replacement permit, you must produce enough of the original permit to determine its complete serial number, and the replacement vehicle must pass the vehicle inspection. You understand that without the original permit and if the replacement vehicle does not meet the minimum compliance requirements, you will not be issued a replacement permit.

### SELF-CONTAINED VEHICLES (SCV)

Self-Contained Vehicles (SCV) and self-contained 4-wheel drive pick-up campers may drive and camp overnight on sections of the ORV corridor with a valid permit. All SCVs must pass a safety equipment inspection and owners must view an educational program and purchase a permit. An SCV is defined as a vehicle with a self-contained water or chemical toilet and permanently installed holding tanks with a minimum 3 day capacity for gray and black water. Rental vehicles prohibited. An SCV permit allows registered operators access April 15 through November 15.

### REQUIRED SAFETY EQUIPMENT & TIRE REQUIREMENTS FOR ORV AND SCV\*:

All vehicles must have the following safety equipment:

- **SHOVEL:** Heavy duty shovel equal to/better than a military folding shovel
- **TOWING DEVICE:** Any of the following which are at least 14 feet long:  
Tow Strap: 1-1/2" Rope: 3/4" Chain 5/16" Cable 1/4"
- **JACK:** Standard size (e.g., vehicle manufacturer's jack)
- **JACK SUPPORT BOARD:**  
Wood: 10 " x 12 " x 1-1/2" or Plywood: 10 " x 12 " x 3/4 "
- **TIRE PRESSURE GAUGE:** must register to 5 p.s.i. or lower
- **SPARE TIRE(s):** must meet regular tire standards outlined below
- **TIRES:** All tires, including the spare tire, must meet or exceed the minimum standards outlined below.
- \* **FIRE EXTINGUISHER:** must be current (SCV only)
- \* **HOLDING TANKS:** PERMANENT, GRAY & BLACK WATER TANKS – minimum 3-day capacity (SCV only)

### BEACH CAMPING IN A SELF-CONTAINED VEHICLE:

Camping is restricted to SCV permittees and allowed in SCV camping areas only on Race Point Beach. Tent and trailer camping is prohibited. Camping is limited to 100 vehicles per night and restricted to 21 nights per vehicle from July 1 through Labor Day.

### Time Limits & Holding Tank Regulations

- All SCV beach camping spaces are available on a first-come, first-served basis.
- All SCVs arriving for an overnight stay must register at the ORV Station before going onto the beach. An overnight authorization permit will be issued at this time. If arriving after hours you must register by 9 AM the following morning.
- If overnight authorizations are not renewed, the vehicle and all personal items must be removed from the beach by 4 PM on the day the authorization expires. Authorizations must be posted with the expiration date clearly visible. Self-contained vehicles may be parked in the designated areas for a maximum total of 21 nights from July 1 through Labor Day.
- SCVs MUST exit the beach after each 72 consecutive hours in order to empty holding tanks at an established dumping facility.

### Travel to Beach & SCV Areas

- SCVs may only travel the beach from either the Race Point north or Race Point south access ramps to the boundaries of the self-contained vehicle areas between April 15 and November 15.

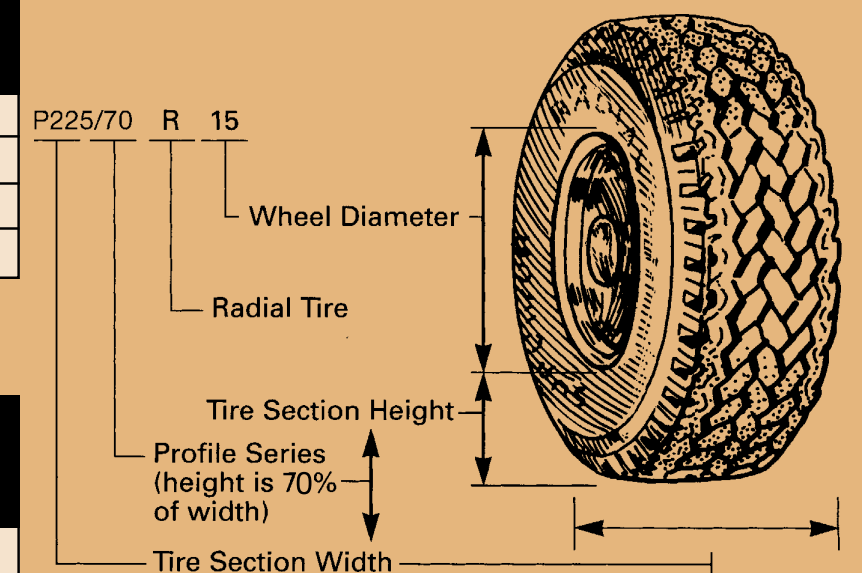

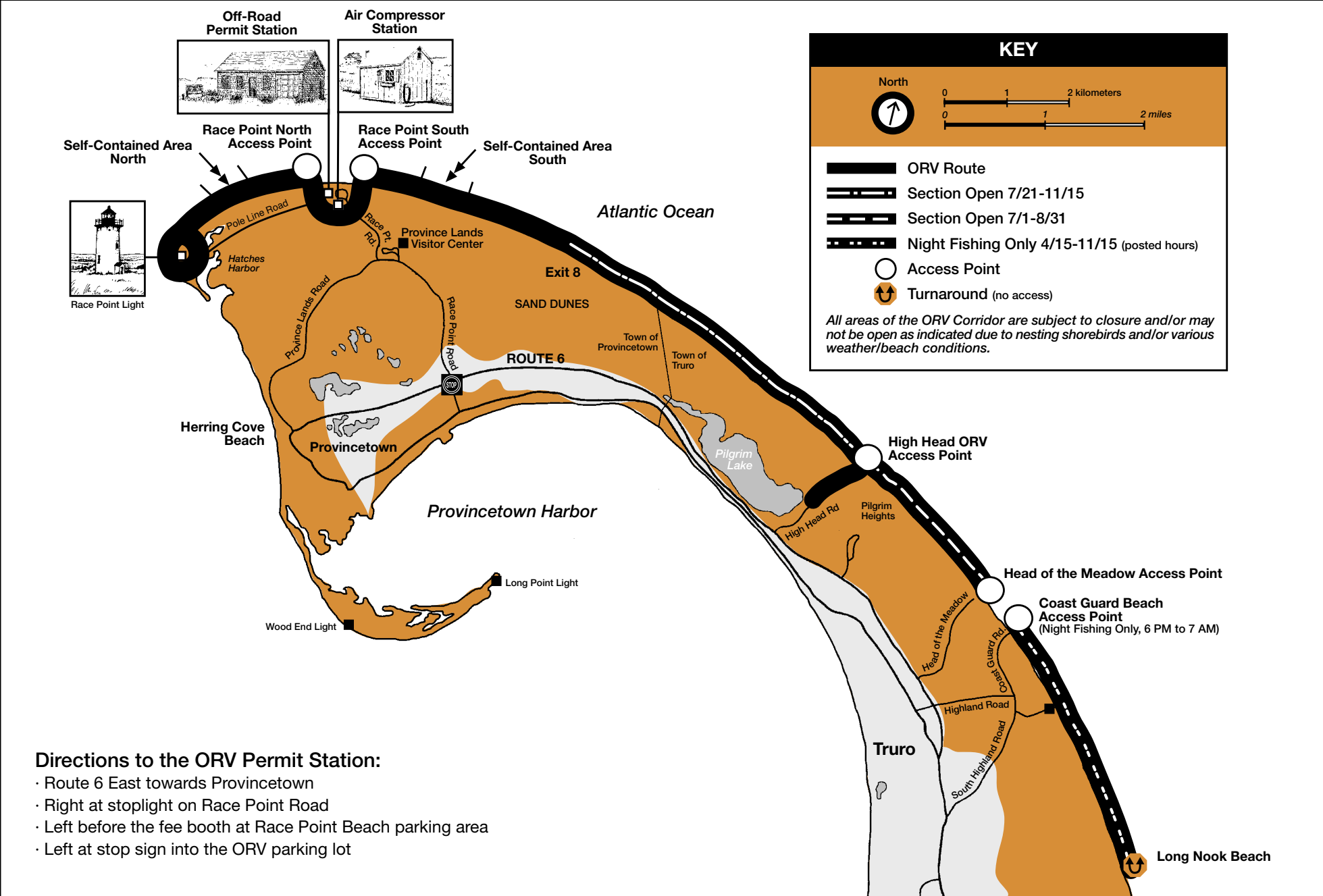

# Off-Road Vehicle Map & Regulations

## ORV REGULATIONS

The ORV Corridor includes the sandy beach route from Race Point Lighthouse in Provincetown to Head of the Meadow Beach in Truro. Coast Guard Beach to Longnook Beach in Truro is open for night fishing only. Sections of the beach are closed during certain times of the season. Always check for current openings and closures. Travel may be restricted at the discretion of park rangers because of changing beach conditions and shorebird nesting activity. Ensuring future enjoyment of Cape Cod National Seashore's ORV route, requires every operator to act responsibly, know, understand and abide by all seashore regulations.

### Driving Corridor

All ORV traffic is limited to the backshore area of the beach, which is the area between the spring high tide line and the normal high tide line. (See Beach Terminology Diagram.) Driving in the dunes is prohibited. All applicable federal and state laws and regulations apply and are enforced. Driving through inner dune routes, posted shorebird nesting areas and lifeguard protected beaches is prohibited. Obey all signs.

### Driving Season & Hours

The off-road vehicle corridor is open for all recreational purposes from 6 AM until midnight daily (April 15 through November 15). Additionally, persons actively fishing may use the corridor 24 hours a day. There is no overnight staying except in the SCV areas in a registered SCV.

### Limited Access Pass

You must obtain a limited access pass in the off season (November 16-April 1). These permits are issued to ORV permit holders. Limited access passes are issued Monday thru Friday, 9 a.m.- 4 p.m.

### Speed Limits

The maximum speed limit on the beach is 15 m.p.h. There is a 5 m.p.h. speed limit in the SCV camping areas and posted shorebird nesting areas. If in doubt, slow down.

### Right of Way & Safety

When two vehicles meet on the beach, the operator of the vehicle with the water on the right has the right of way. Riding on fenders, tailgate, roof, or any exterior portion of a vehicle not designed to carry passengers is prohibited.

### Alcoholic Beverages

All applicable State and Federal roadway laws, including OUI and open containers, will be strictly enforced.

### Pets

Pets are allowed on the ORV corridor except in posted shorebird nesting areas according to the Federal Code of Regulation. Pets must be leashed (maximum 6 foot) or otherwise restrained. Please remove all pet fecal matter.

### Parking

All vehicles and boat trailers must be parked within the posted ORV corridor without obstructing traffic. Parking is not permitted on the inner route at the Race Point Lighthouse (north beach).

### Boats & Personal Water Craft

Boats may be trailer to and launched from anywhere on the ORV corridor. Personal watercraft (e.g., Jet Skis, Sea Doo's, ATVs etc.) are prohibited anywhere in Cape Cod National Seashore.

### Beach Fire Permits

Beach fires are by permit only and are issued at National Seashore Visitor Centers and the Oversand Station. Self-contained stoves or grills, using charcoal or gas, are allowed without a permit.

### Route Maintenance

If your vehicle becomes stuck in the sand, you are responsible for filling in all ruts or holes and removing debris used to extricate the vehicle.

### Clean Beach

Please leave a clean beach. Dumping trash and other debris is prohibited.

## PERMIT SALES POLICIES & PROCEDURES

Permit sales begin on April 10, 2010. Permits have been available throughout the season since 2006.

A total of four hundred (400) weekly permits may be active for any 7-day period throughout the season. An Advanced Sales System exists for 7-day permits, and two hundred (200) of the permits offered are available through this system. The remaining 200 weekly permits will be issued, in person, on a first-come-first-served basis, at the Race Point Oversand Station.

Only 7-Day permits may be obtained through the Advanced Sales System.

When considering a 7-Day permit, be aware that as the Piping Plover population increases, the amount of ORV corridor may decrease significantly, particularly during June and July. **There will be no refunds.**

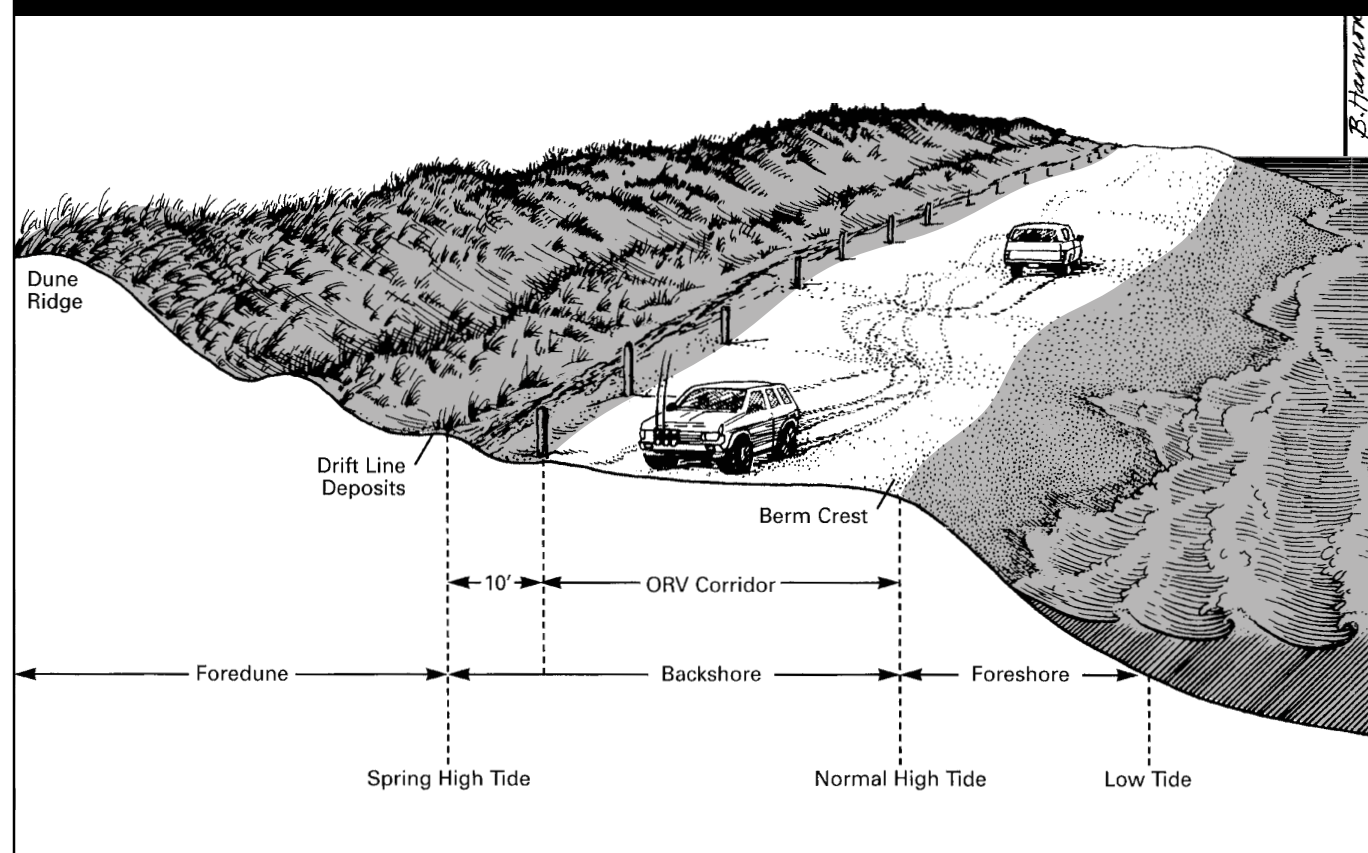
Weekly permits through the Advanced Sales System must be purchased at least one week before the date of issue; the completed request form, with credit card/payment information, must be received by the Oversand Office no later than seven calendar days prior to the requested issue date. More than one week may be requested through the Advanced Sales System or in person. ## BEACH DRIVING TIPS

- **Reduce Tire Pressure to 11 psi** before entering the beach ORV driving corridor. Tire pressure is critical for successful off-road travel in sand. Lower pressure widens the tire surface area and allows your vehicle to float over the sand rather than digging in. Friction may cause pressure to increase while you drive making it necessary to stop and reduce pressure again during your travels.
- **Check a Tide Chart** before entering the off-road corridor. Portions of the beach may be impassable at high tide.
- **Slow Speed** Experienced beach drivers know that successful travel over sand requires a slow, steady speed and correct tire pressure. Remember, "LOW and SLOW... it's the way to go!"
- **Avoid Getting Stuck** If you feel you are in danger of getting stuck — check your tire pressure and let air out, if necessary. Next, try backing up in your tracks before moving ahead. Do not spin tires, this will only cause the vehicle to dig in. Ask for help from another driver or a Park Ranger if necessary. Repair all holes and divets.
- **Proper Gearing** Before entering the off-road sand corridor, shift into 4-wheel drive, high. On hills or other areas, consider going to 4-wheel drive, low.

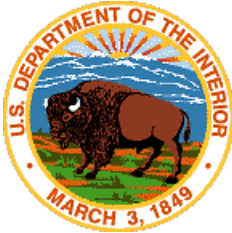

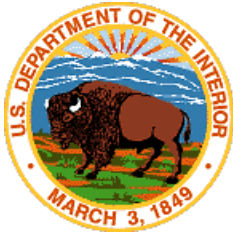
