Hi David,

Thank you for your interest in the Draft Cape Hatteras National Seashore Off-Road Vehicle Management Plan / Environmental Impact Statement (DEIS). Please understand that under the NEPA process once a major planning document such as the DEIS is released to the public, NPS does not typically provide responses to individual questions about the document until the release of the final environmental impact statement (FEIS), at which time written responses to substantive comments will be provided as part of the FEIS. That said, I hope to assist you in finding the information you are seeking. Page 101 of the DEIS identifies the mileage of the beach segment starting 0.5 mile southwest of Ramp 72 within which the "floating area" for non-breeding shorebirds would be located. Page 124 describes how ocean shoreline non-breeding shorebird areas would be managed. If there are specific items in the DEIS that you think need to be clarified or if you have recommendation(s) for how you think something should be handled, you may wish to include that in your comments.

Mike Murray, Hope that all is going well. I had some concerns and questions about Alt. F with regards to the South Point of Ocracoke and was hoping that you could answer them. My concerns are with the "1.0 mile of "floating" ocean shoreline area for nonbreeding shorebirds" that would be 0.5 mile southwest of Ramp 72 to inlet. When you measure that distance that is about all there is 1.0 mile, therefore it won't be floating and if any of the South Point washes away which we all know will happen in the near future the point would or could be closed. Is this Floating ocean closure year around? Throughout much of the year the best fishing doesn't happen right at the "Point" but along this section of beach that you are now proposing to close. The North Point is also proposed to be closed (no Piping Plover nests last 13 yrs) and now almost the entire ocean shoreline of the South Point. I need some help rationalization, this will truly destroy both the spring and the fall fishing seasons if this is allowed to happen. Thanks for your time and response. Thanks David Scott Esham
