Paul,

I've prepared a mock-up ORV brochure text and 15-question "basic knowledge" test, so that we can use it to estimate how long it would take a permit applicant to read the regulations and complete the test (whether it is in person or on-line). Note: The brochure and the test are both very rough first drafts that need to eventually be reviewed and fine tuned to ensure they accurately and efficiently present the relevant information provided in Alternative F. There are also some test methodology issues to address. For example, for many of the questions, the correct answer is "d" which may make it easier to guess the correct answer (or to ell people how to guess the correct answer). We can work on revising the brochure and test questions later. For now, the intent is to simply use these as a representative example of the volume of information and the approximate number of questions that may be contained in the final versions so that we can estimate the amount of time required and include it in the Paperwork Reduction Act section of the proposed rule. It was a struggle to come up with 15 questions, so I think having 10-15 questions seems like about the right range.

By the end of this week if possible, please have several folks (at least

2-3 who are preferably not too familiar with current ORV requirements) sit down, read the brochure and take the test, while keeping track of the amount of time it takes each person to: 1) read the brochure text; and 2) complete the test. They should proceed at a comfortable pace, without rushing through it. The third document is the answer key, which should NOT be provided to the individual. Please provide me with an email summarizing the results and what you think is a reasonable estimate of the time requirements involved.
