Good Afternoon, I do not have an email address for Derb and was hoping you could forward this email to him on my behalf.

Derb I understand that NPS Southeast Regional Director David Vela will be making a short visit to the Outer Banks next week. He has agreed to meet with ORV/access stakeholders and environmental/pedestrian stakeholders regarding the ORV issue while he is here. I hope that you will consider extending an invitation to Dare County to attend the environmental/pedestrian stakeholder meeting.

Dare County has always been a supporter and proponent of pedestrian access. Most recently we have

turned our attention to securing beach access for our pedestrians with parking and bathroom facilities.
