She nested up by the sand fencing and was headed back down to the shoreline when she became misoriented (more than likely it has something to do with the lights being on at the nearby house), then she continued along the side of the house, passed by the Porsche, continued down the street, passed by the trash bins and over some gravel drives and concrete before finally finding her way back over the ramp and back to the water.
