Because of a recent fatality at another park unit, a safety stand down has been issued for all ATV/UTV operations Servicewide. Staff is currently utilizing 4 X 4 pick up trucks to perform turtle patrol throughout the Seashore. The individual covering this route is responsible for the area from Ramp 44 to just N of Buxton. A 4 X 4 vehicle is used to patrol the area from Ramp 44 to the groins. Because of safety concerns through Buxton Village, staff has been walking through Buxton Village to check for turtle nests and crawls. Because of the need for tools and equipment when nests and crawls are located, the technicians will drive as far down the beach as possible so that nests can be found and protected as expeditiously as possible. Because pick up trucks are not the ideal vehicle for detecting turtle nests and crawls, we hope to be reinstating UTV use again in the near future.
