It strikes me as a comment about the "limited access areas" in the weekly beach access reports, specifically those areas, such as a portion of an inlet spit beyond the resource closures, that are (sometimes) identified as being "only accessible by water". Not sure the comment is relevant to the DEIS, although it is possible that under alternative F such situations could occur at inlets. In any case, those kinds of limited access mileages are not discussed or estimated in the plan, nor part of the plan's mileage calculations. As far as the limited access terminology, it only occurs in the weekly beach access reports and on the Google Earth maps and has been used only since the consent decree began and has resulted in these situations. We believe that identifying such locations as "limited access areas" in the current beach access reports is accurate and appropriate to distinguish them as being different than areas "open" to ORVs/pedestrians or pedestrians only.
