Touched base with Matthew and he pointed me to the seaturtle.org website (same one where I got the SC data from last week) which is now a requirement for updating turtle data on in NC beginning this year. It also breaks the data down by species, at least for NC as a whole. So far 850 total turtle nests (822 of which are loggerheads) in NC.

So I will be able to use this data with a footnote that the nesting season is still ongoing.
