The response to your question would be the same as it was the last time you posed this question. Since there are obviously contradictory opinions about how the village areas should be managed during the off-season and why some areas but not others have generally been closed to ORVs in the off-season for many years, and even conflicting opinions as to what dates constitute the "off-season", we are sticking with the status quo approach (i.e., how these areas have been managed in recent years) until the final ORV management plan/EIS (FEIS) is issued.

The final plan will provide the long-term policy for managing the respective village beaches.
