Attached are my comments on 2nd draft of Chapter 3. the comments are minor, but include correcting the 2010 turtle nest count data (should be 153 nests total, with 146 loggerhead and 7 green). As stated in the message below, Britta was only able to review the 1st draft of Chapter 3 and her comments were not submitted in time for Lori to incorporate them into the 2nd draft. Britta's comments on the 1st draft are critical to ensure that the recent breeding season data for all species is accurate. My review of the 2nd draft did not look at the data closely, except for recognizing the obvious that the 2010 turtle nest counts were incorrect. As long as Britta's comments on 1st draft and my comments on the 2nd draft are both incorporated into the camera ready draft, then the park comments will be fully represented.

One thing that needs a quick easy fix is the title for the picture on Pg 227. I would change the wording to American Oystercatcher Chicks near Wrack. The current title refers to a wrackline and there is no obvious "line" in the picture. I did make some changes in the totals for green nests. Sara Schweitzer is working on coming up with a total for PIPL pairs in NC in 2010. She thought she would have one to submit to FWS by the middle of next week. That may be too late for us.
