To answer some questions from you and Britta and to ask a few of my own about chapter 3...

In regards to non-breeding plovers, that discussion does come from Cohen et al 2010 (not 2008) and is found on page 7 of that document. For Britta, the text about Green Island being vegetated and largely unusable to plovers does come from that same section. I will leave it in, unless I hear from you that you would like me to remove it.

Britta, on page 232 of what you sent (under non-breeding AMOY), you make a note that the paragraph is back up from 2008-2010 data, <u>do you have a cite</u> for these non breeding observations you would like us to include?

Sandy, for table 30 you ask about including a footnote, one is included for LETE (letter e in the table notes), the species mentioned in Britta's 9/21 email, is there another footnote that needs to be included?

Sandy, for Socioecon, Beach Driving, you made a note that the section needed to be changed per Butch's changes, are these available, and if not do you know when they will be? Also, are we still waiting on language from Carol regarding ramp counts or will Butch's changes cover what we need there?
