## Sandy,

Your edits look fine to me with one change recommended. See below.

## (revised text)

As soon as practicable after the publication of this Notice of Availability for the ROD in the *Federal Register*, the Seashore will publish for public review and comment a proposed special regulation in the *Federal Register* to designate ORV routes and manage ORV use in the Seashore as described in the selected action. Following promulgation of the final special regulation, the Seashore will begin to implement the **other** (*delete ''other''*)management measures for the selected action, which are described and analyzed in the Preferred Alternative (Alternative F) presented in the Final EIS.

The crux of the discussion in Court yesterday was that we will continue to manage under the consent decree (entirely) until the final rule is completed, THEN some time after the 30-day wait, we would begin to implement the plan/regulation as a whole. There was agreement that we would not make the transition to new procedures during the summer visitation period, which would be difficult for visitors and park staff. Therefore, I would delete "other" from your revised text since it implies something less than "all". As an aside, there will be another Court hearing in Feb or March to summarize/report on the annual reports and to formally request an extension to the consent decree deadline for the final rule.
