Mike,

I tried to attach an mp3 file of the first take of the voice track for the video but is was too long so I will be getting a CD to you this afternoon or Monday. You may hear some breaths or the mic being turned off and on, but that will not be heard in the finished video.

It is well written, but it turns out to be much longer than expected. The voice track alone is around 12 minutes long. If we continue to work with this script, when the video is added, as you may know, it will most likely increase the total run time of the video, by 2 to 3 more minutes, giving us a total time that could exceed 15 minutes. Originally we were shooting for a video that might run as much as 8 total minutes when finished.

Here are some questions.

Is a 14 or 15 minute video too long for the permit applicants to watch?

If that is too long, there are some places, but not many where the information is repeated. Are there some points you would feel comfortable with taking out.

I could talk faster, and that would shorten the voice track and may save some time, but would not shorten the video clips needed to tell the story and we do not want it to sound like

a used car radio commercial.

Is everyone okay with a longer video? If so it will require some additional shooting and editing time. I can give you an estimate for that if we move in that direction.

I look forward to hearing back from you after you have a chance to listen to it.
