

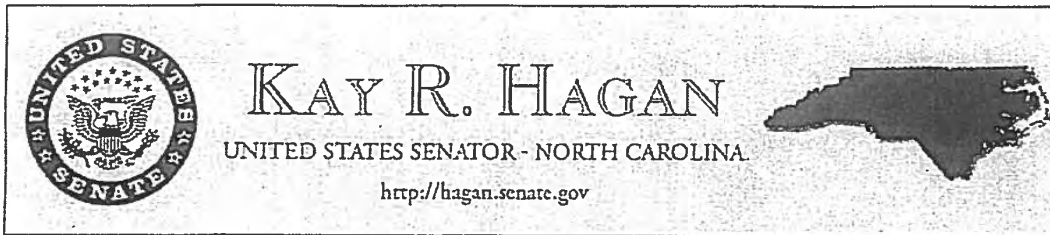
Dear Ms. Hackett:
