# Priscilla,

We've been embroiled in a controversy for 5+ years over the management of off-road vehicles (ORVs) on Seashore beaches. In essence, the NPS has failed to comply for over 30 years with executive orders and an NPS regulation that requires us to designate ORV routes (i.e., limit ORV use) and minimize the impacts of ORVs on wildlife and wildlife habitat, minimizes user conflicts, and provides for the safety of all visitors. We were sued in late 2007 and have managed ORVs and protected bird and sea turtle nesting areas in accordance with a court order/consent decree since late April 2008. We have recently completed a long-term ORV management plan/EIS, and are in the process of preparing a special regulation, to comply with executive orders and NPS regulation regarding ORV on park lands and to replace the management measures implemented under the consent decree.

See below FYI, which is representative of some of the ORV user comments we receive. For several years, ORV advocates have been making the argument, among many arguments they make that NPS should provide as much ORV access to Seashore beaches as possible, that ORV access is needed to provide handicap accessible access to remote undeveloped beach locations at the Seashore. For example, Cape Point, the location being discussed in the message, is a popular surf fishing area that is approximately 1.5 miles from the nearest paved road and also very important shorebird nesting habitat. Access to the Point is currently limited to pedestrians due to resource protection closures implemented in accordance with the consent decree. DOI Solicitors Mike Stevens and Jason Waanders have been advising us on all issues related to ORV management (including the accessibility issue) and reviewed our response to Mr. Lamphier, which is consistent with our response to comments on the issue in the November 2010 final ORV management plan/EIS (FEIS).

We want to make you aware of the issue, in case we receive a formal complaint.

The National Park Service (NPS) recognizes that visitors to the Seashore have different needs, and therefore provides a variety of uses, including both ORV and vehicle-free areas. This is in line with the applicable requirements and NPS policies. Under the Rehabilitation Act, 29 U.S.C. § 791 et seq., which applies to federal agencies in lieu of the Americans with Disabilities Act of 1990 (ADA), the NPS is required to provide reasonable access to programs and services at the Seashore. âReasonableâ does not necessarily mean âtotalâ and must be viewed in the light of the

entire program or activity, including its purpose (i.e., providing the visitor with a variety of experiences). Likewise, NPS must comply with legal requirements and best available science related to the protection of park resources, including the protected species of shorebirds and sea turtles that nest on the Seashore's beaches.

In this case, the current temporary off-road vehicle (ORV) access restriction to Cape Point complies with the court order/consent decree under which the NPS must operate until the long-term ORV management plan and special regulation are completed. Despite the temporary restriction, there are many other locations within the Seashore that are currently open to ORV access, including popular fishing spots.
