Bob,

The predator control program has clearly been beneficial for beach nesting birds, but it is difficult to quantify its relative contribution to nesting results. As you know, multiple factors affect nesting success each year including weather, predation and management of human disturbance. Based on advice from FWS, park staff refined our record keeping in 2010 so that in the future we can analyze and compare trends in "catch per unit trapping effort" from year to year. In principle, if trapping effort is sufficient to reduce the density of predators present in a nesting area, we would expect to see a decline in catch per unit effort over time at that site.
