I don't believe that including a 'distance to nest' measurement would be helpful. Although violations can occur inside the filter fencing, and still be several feet away from the nest, any violation inside the filter fencing is a threat to the hatchlings. If the footprints/tire tracks are not cleared from the area hatchlings could get caught in them and get disoriented or die.

I think that violations anywhere inside the filter fencing have the same significance and a separate category of 'distance from the nest' would not be useful.

Does anyone else have thoughts about this?

Just one minor suggestion. On the violations within the filter fencing, with no nest "disturbance", how about adding an estimated distance from the nest. My thinking is that portions of the interior of the filter fencing, in some situations, can be a great distance from the nest and because of this lack of proximity may not represent much of a threat to the nest.

In reviewing the latest Resources Management Field Summary (For July 28 - August 3, 2011), it is evident that most of the closure intrusions that are occurring relate to

turtle nest expansion. It is sometimes difficult to tell from the description of the intrusion how serious the intrusion was. For example, was the intrusion of minor significance such as someone walking through the inter-tidal zone below the closure signage, or was it something much more serious such as a person or pet going into the filter fencing where the nest is located?

In thinking ahead, I want us to be in a position to re-evaluate the turtle nest buffer expansion parameters in five years when we conduct the 5-year periodic review of the ORV plan and related resource management strategies. It will be very helpful at that time if we have been collecting documentation about turtle expansion intrusions that differentiated between and provided totals of minor, inconsequential violations vs. those that are potential more serious. I discussed this yesterday with Britta and she agreed with me in principle (i.e., that standardizing our reporting to differentiate between minor and more serious intrusion violations, although we did not have time to work out the specific wording I am proposing below.

Please review the draft standardized wording below and offer suggestions/comments by COB on Tuesday, August 9.
