Jami,

If Marianne told Mr. Clark that his comments to Senator Hagan would be considered as public comments by the NPS, then she needs to inform him of the process for submitting comments for consideration. See attached FR Notice.

The underlying issue (and Mr. Clark's correspondence is but one example) is that, <u>as a communications tactic encouraged by some of the stakeholder organizations</u>, many constituents are routinely copying Congressional delegation members on their public comments on the proposed rule (or are sending the delegation "concerns" during the public comment period in order to influence political opinion). There is a disconnect between the controlled correspondence process and the public comment process, and WASO is automatically assigning SER to respond to these without realizing that NPS is in a public comment period on a controversial issue. As you know, the process for responding to the properly submitted public comments on the proposed rule are to address them in the comment summary section of the final rule. We do not respond individually to comments submitted through the official public comment process and (in my opinion) should not respond individually to comments that, in essence, by-bass the comment process by routing them through the Congressional representatives. The workload alone in doing so would be unmanageable, but I suspect it would also create procedural problems since it is inconsistent with how we normally respond to public comments.

The best solution would be for WASO to come up with a standardized way to handle the Congressional "inquiries" (which often simply forward a constituent's "concerns" about a proposed management action) that occur on <u>any</u> park management issue (not just ORVs at CAHA) that is open public comment period. My suggestion would be for WASO to get the Solicitors to review a standardized response that would be along the lines of (wordsmith as needed): "Dear Congressman _______, Thank you for your inquiry. The matter of interest to your constituent is currently open to public comment. In order for NPS to consider the constituent's concerns, the comments must be submitted in accordance with the procedures described in the attached Federal Register Notice. Thank you for your interest."
