FYI - I've tried to redirect Bob's focus toward problem solving and coming up with some dates that work. See his response below.

Also, a local district court judge just issued an order (received here after business hours yesterday) stemming from a reckless (ORV) driving case that was heard late on Monday. See attached. It is not an injunction, but affirms the NPS resource protection mission and confirms the NPS responsibility to complete the plan and regulation. The case occurred late Monday afternoon and the judge verbally indicated he would issue an order, though we did not know what to expect. I heard about it Monday evening. We felt we needed to have a better understanding of the situation before notifying stakeholders. Stakeholders learned of the pending order on their own (possibly from the defendant?, since there were no reporters or other audience in court as it was the last case of the day) and spread the word. Yesterday the anticipation of the order, and not knowing what it would say (would it be an injunction, etc.?), created quite a stir among stakeholders. Spent quite of bit of time, in the middle of a visit from our Regional Director, touching bases with stakeholders (we met with some of the ORV group leaders in Buxton and responded to lots of phone calls). We will forward information (copy of the order, etc.) to stakeholders this morning. NPS is discussing with DOI and DOJ attorneys today to determine how to respond.

Clearly you are frustrated with the choice of the proposed dates for the next workshop. Nonetheless, I need to emphatically request that you refrain from making abusive comments about the facilitation team. They are doing their very best to accommodate and be responsive to <u>many</u> different perspectives and needs - not just yours.

At the last Negotiated Rulemaking workshop in May, when asked about the scheduling of future meetings, folks generally indicated that the summer months were their busiest time and to wait until the fall for the next meeting.

The facilitation team provided three options with the intention of identifying which dates would work for most people. No dates will ever be perfect for everyone. To charge that the facilitation team is being biased or stupid is simply not accurate. Furthermore, I think you understand that personal attacks are not conducive to establishing the kind of respectful and positive working relations that will be required to jointly solve Cape Hatteras's ORV management challenges.

Once the Negotiated Rulemaking Committee is convened, the members will be setting the schedule for their meetings. And again, no dates will be perfect for everyone. But hopefully, the Committee will do their best to address the different needs and scheduling constraints of members. Also, the designated Alternates will be able to participate and ensure representation on those occasions when a member is unable to attend.
