From Rocky Mount: Take HWY64 East to Manteo, 64 East changes to HWY 158 (Bypass) at the Whalebone Intersection in Nags Head. Stay on the Bypass for approx. 2 miles, look for the Town of Nags Head water tower on right merge into center lane just ahead of the water tower Fire Station is on left north of Village at Nags Head.

From Elizabeth City: Take HWY 158 East to Nags Head travel south past the Outer Banks Mall, Food Lion and the BB&T Bank - the Fire Station will be next on the right. The Municipal Complex is in front of the water tower on left.

PARKING

Parking is limited at the Fire Hall. Please park in the southeast overflow parking lot at the Town of Nags Head Municipal Complex, located in front of the water tower. There will be a Nags Head police officer there to escort participants across the 4 lane highway to the fire station. Be safe!
