> Robert and I are doing a bit more thinking about the routes and areas
> meeting 1 of May. We are thinking the following. Maybe you can give me a
> call or let me know who among your staff we should talk to about preparing
> for that meeting in terms of maps. Below are a few ideas.

> It would be good to have a map we can project via powerpoint/GIS we can
> project on the wall if it's easy so the group can focus on one map. The
> maps we used last meeting may not be high enough in resolution/scale to
> focus on the level of detail we'll probably need to do in that meeting.
> We're thinking we'll want to talk about ramps, parking, alternative routes,
> if any. An alternative choice is to have some bigger maps we can lay down
> on a table and write on in detail, and maybe have a few copies of each.
> Individual maps for everyone probably just make it hard to keep everyone
> focused on one thing, so we don't think we'll need individual copies.

> We thought we would go through each section of the Park and try to begin to
> develop an underlying "base map" of routes and areas designated for
> driving,
> even if some of these areas are closed due to Village, ORV Safety, or
> Natural Resource closures. We thought we would try and identify where most
> or all agree a route should be designated, any areas where everyone agrees
> there shouldn't be areas designated, and the areas of contention. We will
> also need to focus on the issue of changing geography on the ground due to
> the dynamic nature of the place and how to account for that in
> maps/designations. Since Steve Kayota can't likely make this meeting,
> we'll
> probably need to set the driving in front of the villages aside until a
> later time under either Village Closure as a topic or at the May meeting.
