Please find the attached reviewed publication which is now "In Press" for "Ecological Applications". Some of you have had questions/concerns about the number of sea turtle nests that go unfound by volunteers. This is the latest study that has been done on the subject and has a much larger sample size than the one I cited earlier. Although this study took place in Florida, the volunteers and workers that surveyed the beaches were very well trained and have (for the most part) been conducting surveys for many years. Some of the index beaches in this survey get more disturbance than those on Cape Hatteras N. S., and others get less disturbance. The manuscript is long (89 pp.), so I draw your attention to the section entitled "Quality assurance and quality control of nest-count data" on pages 8-10. Note that regarding the finding of sea turtle nests, it states "The false-negative rate (100%-sensitivity) was 8.7% (95% CI: 6.0 - 11.9%)"
This means the workers missed 8.7% of the nests, even when they found crawls. They did not try to quantify the additional nests that were missed because no crawl was found. That would of course involve a much more detailed study.
