In addition to the pre-nesting closures and pedestrian closures that provide habitat for migratory and wintering, non-breeding birds, the Park will provide the following to protect habitat and human access.

The Park will:

- Establish at least XX miles of "migratory and winter oceanside areas" on Hatteras Island (plus or minus 10% to account for establishment in relation to ramps, natural barriers, etc.). Each area will be at least .5 miles in length (parallel to the tide line).
- Ocracoke Island already addresses these kinds of habitat through numerous pedestrian-only areas.
- The areas will be established seasonally at the time adjacent or near-by pre-nesting closures reopen for access. This time will likely range from July 31 into September.
- The areas will be selected each year, given the dynamic nature of the beach, for preferred habitat for a host of shore birds, including, but not limited to ______. The areas will be selected in consultation with FWS and NCWC.
- The areas will range from the high tide line to 50 m upland (50 m perpendicular from the high tide line). The area may be as wide as 40 m at a few points along the area/corridor, in order to allow a sufficient ORV area to be established.
- Areas will be selected to ensure clear, extensive, accessible egress and exit by pedestrians and their diverse activities, primarily through an upland section of beach wide enough for ORV passage two way and parking for ORVs. Thus, most areas will be areas of wider beach. Access for these areas only via an interdunal road will generally not be appropriate, unless that interdunal road provides for sufficient two way traffic, sufficient parking, and extensive beach cuts (every 100 yards or so).
- These areas will allow for full pedestrian access during the times they are established. Pedestrian access will not be limited in these areas.
- The areas will be clearly marked on maps for users and on-site via some kind of symbolic fencing.
- The Park may issue special permits for fishing tournaments that will allow for ORV access for limited times during the year into these areas.
