Dan and Janet,

The facilitators and I have determined that it is highly beneficial to give the RegNeg Committee a little more time to resolve the remaining unresolved issues, while maintaining the urgency to keep on schedule in order to meet the Consent Decree deadline for the plan and regulation. We have submitted a Federal Register Notice to WASO (fedex should have arrived yesterday) to schedule one last regulatory negotiation meeting on February 26-27, 2009. (In essence, we have cancelled a 2-day meeting on Jan 21-22 to allow more time for subcommittees to work out the unresolved issues and are re-scheduling the 2-day full committee meeting on Feb 26-27 for final deliberations).

We know we are cutting it close on getting the FR Notice published for the late Feb meeting. It is a basic advisory meeting notice with no associated draft plans or documents that need to be reviewed. We have already contacted Duncan Morrow and Debra Melton, and left messages for Jerry Buckbinder, so key NPS staff who help process the notice are apprised and ready to act. We primarily need expeditious review and approval by your respective offices.

We would appreciate any assistance you can provide in expediting the FR Notice review by NPS and DOI.
