Hi Jim,

My hope in sharing this with the sub-committee at this time was to let you guys know, as specifically as I can state it, where FWS is coming from. I don't want to steer or otherwise prejudice the negotiations of the sub-committee; I just want you guys to have as much information as possible as you begin your work.
