14	and modify wildlife buffers in the National Seashore in
15	accordance with this section and any other applicable law.
16	(b) BUFFER MODIFICATIONS.—In modifying wildlife
17	buffers under subsection (a), the Secretary shall, using
18	adaptive management practices—
19	(1) ensure that the buffers are of the shortest
20	duration and cover the smallest area necessary to
21	protect a species, as determined in accordance with
22	peer-reviewed scientific data; and

cause of wildlife buffers, to allow access to areas

3 (c) COORDINATION WITH STATE.—The Secretary,
4 after coordinating with the State, shall determine appro5 priate buffer protections for species that are not listed
6 under the Endangered Species Act of 1973 (16 U.S.C.
7 1531 et seq.), but that are identified for protection under
8 State law.

9 SEC. 4. MODIFICATIONS TO FINAL RULE.

10 The Secretary shall undertake a public process to
11 consider, consistent with management requirements at the
12 National Seashore, the following changes to the Final
13 Rule:

(1) Opening beaches at the National Seashore
that are closed to night driving restrictions, by opening beach segments each morning on a rolling basis
as daily management reviews are completed.

18 (2) Extending seasonal off-road vehicle routes
19 for additional periods in the Fall and Spring if off20 road vehicle use would not create resource manage21 ment problems at the National Seashore.

(3) Modifying the size and location of vehicle-free areas.

1 SEC. 5. CONSTRUCTION OF NEW VEHICLE ACCESS POINTS.

2 The Secretary shall construct new vehicle access3 points and roads at the National Seashore—

4 (1) as expeditiously as practicable; and

- 5 (2) in accordance with applicable management
- 6 plans for the National Seashore.

7 SEC. 6. REPORT.

8 The Secretary shall report to Congress within 1 year
9 after the date of enactment of this Act on measures taken
10 to implement this Act.
